

#### #R2011-177 APPALACHIAN TRAIL COMMUNITY DESIGNATION

Motion Supervisor Sweeton, seconded Councilman Gerstner to adopt the following resolution:

WHEREAS, the Appalachian Trail (A.T.) traces its roots to the 1920's and was designated America's first national scenic trail in 1968; and

WHEREAS, today through the efforts of volunteers, clubs and agency partners, the Appalachian Trail extends more than 2,175 miles from Maine to Georgia within a protected 250,000 acre greenway; and

WHERAS, towns, counties, and communities along the Trail's corridor are considered an asset by A.T. hikers and many of these towns act as good friends and neighbors to the Trail; and

WHEREAS, designations as an Appalachian Trail Community™ and participation in the program is designed to act as a catalyst for enhancing economic development, engaging community citizens as Trail visitors and stewards and helping local community members to see the Trail as an educational and environmental resource and asset; and

WHEREAS, the Town of Warwick's application to seek this designation has support from the Warwick Valley Central School District, the Villages of Warwick, Greenwood Lake and Florida within the Town, the Warwick Valley Chamber of Commerce, the Pine Island Chamber of Commerce and the local Appalachian Trail Conservancy.

NOW THEREFORE, the Town Board of the Town of Warwick does hereby resolve to support the efforts to be designated an Appalachian Trail Community and participate in this program for no less than five (5) years by serving as a member of the Advisory Committee formed to guide the community's activities in conjunction with the Appalachian Trail Conservancy.

Motion Carried (5 ayes, 0 nays) Supervisor declared this resolution duly adopted.

#### 1) Advisory committee:

The advisory committee was formed after an informal discussion between Warwick resident and NYNJ Trail Conference volunteer Gene Giordano, Michael Sweeton, Warwick Town Supervisor and Michael Johndrow, Director Warwick Valley Chamber of Commerce. A formal presentation was then made by Mr. Giordano to the Warwick Valley Chamber of Commerce Executive Board which then voted to work towards obtaining the Appalachian Trail Community designation. Other interested parties were invited to participate and include local government, small business, non-profit organizations, education and private citizens. Committee membership is open to the public. The mission of the advisory committee is to work with the Appalachian Trail Conservancy representative and act as liaison between the Town, local school districts, local businesses, NYNJ Trail Conference and other organizations. The Committee uses a list-serve to discuss ideas and business, with meetings scheduled on an as-needed basis. Gene Giordano serves as the Committee Chair for putting together the committee's AT Community designation application and the first year if Warwick receives such designation. Henceforth the Committee Chair will be elected annually by the committee.

In addition to involving the local school districts in the application process and ongoing Appalachian Trail related curriculum, the advisory committee sought to reach out to the local community-at-large to present the Trail Community Designation proposal, offer information on the Appalachian Trail and solicit feedback from the community. Two community meetings were held in August 2011; one in the Village of Greenwood Lake at the Greenwood Lake Public Library and one in the Village of Warwick at the Albert Wisner Public Library. The meetings consisted of a Keynote presentation offering a tour of the Appalachian Trail and information on both the Trail Community and Trails to Every Classroom programs. The presentations were given by Gene Giordano, Advisory Committee Chair - NY-NJ Trail Conference NJAT Committee Chair along with Gail Neffinger, NY-NJ Trail Conference Orange-Rockland Chair. The presentations were wellattended and well-received by the community. From these meetings it was evident that many in the community though aware of the Appalachian Trail, seek more information on the trail such as parking availability and suggested hikes and difficulty of hikes. The advisory committee will make this information available to the community and also schedule regular Appalachian Trail hikes in conjunction with Orange Pathways, a local group that leads hikes.

The Advisory Committee will also sponsor a booth at our very popular Warwick Valley Farmers Market on October 16, 2011 where information on the Trail Community designation will be offered along with general Appalachian Trail hiking information. Advisory committee member Les Ferguson, a Warwick resident and the NY-NJ Trail Conference maintainer for the AT from Route 17A to Cascade Lake in Warwick will offer this presentation. We will continue to reach out to the community through a variety of means. The sponsorship of a booth at the Warwick Valley Farmer's Market and a family Appalachian Trail hike will be annual events.

Warwick was the first town in New York to codify protection of the A.T. in the 1970's. Town of Warwick zoning code, chapter 164-22:

DESIGNATED PROTECTION AREA[Amended 9-11-2003 by L.L. No. 4-2003] A. Areas within which the changing of land contours and/or the removal of the natural vegetative cover and/or the erection of structures is automatically subject to approval of plans and authorization by the Planning Board, according to § 164-46, upon the advice of the Town Environmental Conservation Board and the Town Architectural Review Board, for purposes of protecting ecologically sensitive areas and scenic assets of the community, except that the interior alteration and minor exterior alteration of structures shall not require authorization by the Planning Board. Such minor exterior or interior alterations shall require only the approval of the Building Inspector and issuance of a building permit. Those areas so designated, except those portions that border or lie within portions of the Agricultural (black dirt) District are as follows: [Amended 2-18-2010 by L.L. No. 1-2010]

- 1. (1) The Appalachian Trail.
- 2. (2) The Doublekill Stream from the Sussex County, New Jersey, line to its

junction with the Wawayanda Creek in the New Milford area.

- (3) The Wawayanda Creek from its Wickham Lake outlet to the Sussex County, New Jersey, line.
- (4) The Longhouse Creek from the Passaic County, New Jersey, line to its junction with the Wawayanda Creek in the Wisner Road area.
- (5) The Pochuck Creek from the Sussex County, New Jersey, line to its junction with the Wallkill River.
- (6) Trout Brook from its source [Warwick Quadrangle, United States Geological Survey Maps, longitude: seventy-four degrees fifteen minutes nineteen seconds (74° (degrees) 15' 19") west; latitude: forty-one degrees fifteen minutes thirteen seconds (41° 15' 13") north; elevation: 1,040 feet to the Chester Town line.
- (7) Greenwood Lake, Glenmere Lake, Sterling Lake, Wickham Lake, Sterling Forest Lake, Little Cedar Pond, Ro-Lyn Lake, Cascade Lake, Sandy Beach Lake, Village of Warwick reservoirs and all streams feeding this reservoir system, and all other lakes and ponds, if any, over 10 acres in surface area.
- (8) The 100 foot setback requirements identified in the Table of Bulk RequirementsEN as "designated protection areas" shall be interpreted to mean that measurement be made from the banks of streams or the mean high water mark of shorelines of lakes, and also from the center of the Appalachian Trail

To the Members of the Appalachian Trail Conservancy,

My name is Chris Graven and I live in Warwick, New York. Although I was born elsewhere, I moved to Warwick fifteen years ago and consider it my true hometown. Over the years Warwick has undergone various changes, many of them environmental, and I strongly hope that one more may come in the form of Warwick being named an Appalachian Trail Community.

As a kid of about eight years old, I had my first experience with the Appalachian Trail. I remember hiking the trail with my parents, talking, laughing, and enjoying the solace of nature, the undisturbed beauty engulfing the view. I was in complete disbelief that a place so beautiful, so natural could exist so close to the little town I had grown to love. It is an area like one would see in a magazine and nobody ever believes they can get to these places and see them with their own eyes. Well, I have one in my own backyard. Ten years later, I can sit and reflect about all the memories I have made on the trail. Whether it be the times a group of my friends and I hiked the trail to find a beautiful spot just to eat lunch for an hour away from everybody, walking the trail with my family to provide the time and place to just talk to each other and not be bogged down by technology, or simply the times I walked the trail by myself, just taking in my surroundings, watching the birds, snakes, deer and seeing the majestic views that this trail provides, I can honestly say that the section of the Appalachian Trail that runs Warwick will always be a part of the person I am. This being said, I would love to see it preserved and Warwick turned into an Appalachian Trail community to it may continue to provide the solace and escape from development and technology as well as just cherished memories to those who will live in my beloved hometown in the future.

Beyond the aesthetic beauty, I strongly believe that Warwick has much to offer to the Appalachian Trail as well as the hikers, as the trail and hikers have much to offer community. First of all, Warwick is a very green community. Although we are a very small town, we do have public transportation to cut down on greenhouse gas emissions from drivers commuting to the city for work. Everywhere one looks, there are bikes, bike racks, and people walking. In addition, our school has been using solar panels for the last nine years or so and has been annually cutting down on their electricity consumption from environmentally polluting sources. A windmill project is even in the works and is looking to be completed within the next few years. A town so mindful of the environment and so willing to make necessary changes to protect it, would obviously be a good fit as an Appalachian Trail community. We have already proven ourselves good stewards of the environment and this would only expand to encompass the Appalachian Trail if we were given such an opportunity. While walking the trail my last time out, I stopped to talk with a couple hikers, a man and his girlfriend from Georgia. They were several minutes from the Warwick stop in the trail and asked me where The Creamery was. Two twenty year olds, from several thousand miles away in a totally different culture, had heard about our ice cream stand that is located along the trail and makes real, homemade ice cream. Not only is it famous in Warwick, but throughout the Appalachian Trail community. The trail community knows Warwick already and loves what they know. If we were named an Appalachian Trail community, these hikers would further explore Warwick, finding more to love and appreciate.

Even as the small town that we are, Warwick has several places for travelers to stay. Right along the main strip in town, we have several bed and breakfasts as well as two motels. They are family run, giving both the small town caring and love with a comfortable bed and smiling faces. They are not a large chain hotel where everybody is a customer and you just get a room, the travelers that stay here in Warwick are people, each with a story to tell.

The "problem" of who will maintain the trail and clean it is really no problem at all. Our community, being so green, would surely accept the responsibility, and if by some slight chance they don't, our environmental program here at Warwick Valley High School could surely do it. Annually, we have over 200 students participating in our environmental program, learning all year how to protect and serve the environment. Basically, each year Warwick creates 200 new environmentalists looking for a natural solace like this that they can call our own. The program has already adopted a road and maintains its cleanliness as well as being in charge of the lake out back of our school. All is handled more than sufficiently and has proven that great responsibilities can and will be handled by this program.

Again, Warwick is home to many small, family run businesses. Whether it is the plethora of restaurants located here, each serving different yet still delicious food, or the bike shop, or even the instrument store, there are a lot of great people with great businesses. The great people here are the reason I fell in love with

Warwick in the first place and consider it my true hometown. Warwick being named an Appalachian Trail community would help all of these great, loving, and friendly people by attracting more customers in to the town of Warwick and raising the awareness of our town in general. With more revenue coming in to these people and the town, we can continue to build and expand what we have started here with more environmental projects designed around teaching the preservation of the trail, new stores centered selling hiking boots, backpacks, and water bottles, and financing further projects such as our windmill and more solar panels. Either way you look at it, through the eyes of Warwick or through the eyes of the hikers, it is a win-win situation.

I truly believe Warwick, New York would make a great Appalachian Trail community. Thank you for your time in reading this letter and in your time deliberating designation.
